Generator – Cllr. Milne reported on regulations regarding the storage of gas cylinders, this has to be outside of the building. He will contact Burns for confirmation. Cllrs. Milne & Wotton will meet to measure for the storage unit.

4. Cllr. Brazil's Report- DCC – Slapton Line – the date for reopening of this road is now 26th October 2018.

Cllr. Brazil had attended a briefing on Ash – dieback, 95/98% of ash trees will succomb to this disease, 20% of all the trees in Devon. The owners of diseased trees are responsible for their removal only if they are a danger to the public. There are trees in our Parish affected. There is no free tree scheme available at DCC or SHDC at present. He had attended a Harbour Board meeting, the harbour has enjoyed a very successful summer this year, nothing from the meeting affects South Pool.

SHDC – are progressing with their commercial investment programme, The Invest to Earn Scheme.

eg:- building a Health & Wellbeing centre in Dartmouth SHDC have a turnover of 75million so are able to borrow up to 75million for these projects. Decisions on projects will be taken by Officers, Councillors and the Executive committee.

Collection of rubbish – are still looking to outsource this collection. Public Toilets – pay as you enter machines have been put out to tender.

A question was asked – how much will it cost to join the Customer Service Membership. Not know at this time
