Drains – A Parishioner is concerned there are not enough drains between Longcross and the village following the heavy rain on Sunday, The Millbrook came close to flooding again.

Oak Tree – David Bennett has donated a replacement oak tree for Broken Pound, to be planted in November. He has grown this plant from a South Pool acorn.
